



Dear Traveler,

I hope you are doing well and are eager to see the Beauty of God's Creation again. As the United States starts to open up we are excited to start traveling again, but keep in mind your safety is a top priority of ours. Here are some of the procedures that R & J Tours will be implementing to promote wellbeing.

Health & Safety:

Staff & Passengers are asked to wear a mask (you need to bring your own) when a state requires one or when a public event/vendor requires you to wear one. While in states that mandate masks, we recommend following the requirements when you are able to. If our tour director notices you are without a face covering, they will assume that you have a medical condition that exempts you from this order. Due to HIPAA privacy, the tour director will not ask about your condition. We ask that you be kind and considerate to one another during the tour. We also strongly recommend using the hand sanitizer when getting on/off the motorcoach.

Motorcoach Cleanliness:

We use Thielen Bus Lines for most of our trips. They have a very strict policy on cleaning of the motorcoach. A copy of that can be provided to you if you wish to read it. It includes pre-trip & post-trip cleaning of the motorcoach. Our tour directors & driver will be doing daily maintenance cleaning during the trip.

Reduced Capacity:

We are going to travel in a smaller group size for the time being. Our travel size will vary, but we will try to keep it limited to 26-30 people or less on each trip. Your seat assignment will be a random draw when you arrive at the motorcoach. That will be your assigned seat for the entirety of the trip. Passengers will be reminded of social distancing.

Waiver & Questionnaire added:

Please don't be overwhelmed by the legality of these forms. We are following the guidelines of the ABA & NTA as they advise these procedures be implemented.

Please read through the waiver agreement and sign the customer copy. There is also a required COVID-19 Traveler Questionnaire that you will receive with your pre-trip packet. Please give these completed papers to your tour director on the first day.

After reading our safety protocol, if you are uncomfortable traveling at this time, it would be best to transfer or cancel your tour before final payment is due.
